## What Are GMOs?

A genetically engineered food (GE or GM plant or meat product that has had it DNA artificially altered in a laboratory by genes from other plants, animals, viruses or bacteria in order to produce foreign compounds in that food. This type of gene alteration is not found in nature. Many o the foods we currently eat have been genetically altered and **we don't know** which ones without labeling.
